Dear Seattle Intellectual Property Inn of Court Member:

Welcome to the 2020-2021 program year for the Seattle Intellectual Property American Inn of Court! The Executive Committee has been working all summer to ensure that we have a robust and collegial Inn experience despite the challenges from COVID-19. We hope that you are healthy, and that you will join us at our first virtual meeting on September 24 to kick off the year.

We have organized the year around the assumption that Fall meetings will be on-line, and that we will need to be flexible in the Spring. Here are some of the highlights we have planned:

- Seven for-credit CLE programs, including at least one ethics CLE
- Happy Hours
- Small group meeting sessions
- Enhanced Mentor program involving small group discussions and presentations on career paths
- Joint Inn Meeting with the Hon. Robert J. Bryan Inn and the William L. Dwyer Inn

As we have done in the past, we have divided our approximately 125 active members into seven pupilage teams dedicated to making our meetings informative, entertaining, and a valuable source of CLE credit and networking. We have taken special care to ensure that each team is a mix of Masters, Barristers, Associates and students, as well as to ensure a mix of corporate inhouse, firm, solo practitioner and other work experiences. We will follow our usual practice of asking each team to be responsible for the planning of one CLE, which provides you with an opportunity for personal interaction, peer learning and to showcase or practice your presentation skills.

Plans for meetings

Our Fall meetings (September - December) will take place on-line using Zoom technology (provided by the University of Washington). Incoming student members will meet on September 17 for orientation. We plan to dedicate the first meeting on September 24 to get to know each other in our pupilage groups and to host questions and comments about the year.

After September we will begin regular monthly CLE presentations. We will also host additional small group and mentor meetings, which we have added to allow more personal interactions and networking. Topics for the small group meetings will be developed throughout the year.

We hope to resume in-person meetings in the Spring at our usual location at the University of Washington Faculty Club, or possibly another location in Seattle. However, we will need to be flexible to accommodate changing circumstances.
